# Article 2-.

The coordination task force for preparedness, emergency response and recovery of the National Committee for Disaster Management consisted of the United Nations Resident Coordinator and UNDP Resident Representative for the Kingdom of Cambodia as an advisor.

# Article 3-.

### The coordination task force has the following tasks and responsibilities:

- To coordinate of the leading and collaboration with Royal Government Ministries-Institutions, Cambodian Red Cross, United Nations Resident Coordinator, development partners, international-national organizations in formulating and laying out the measure of disaster preparedness, emergency response and recovery.
- To mobilize the equipment, material, mean of transport, human resource and finance and receive the voluntary fund or generous humanitarian assistance from international-national organizations as well as charitable persons either at home or abroad for the emergency response and recovery during disaster occurring.
- To disseminate the disaster situation and receive information from vertical line of NCDM (municipality-province, city-district, khan, commune-sangkat authorities), Royal Government Ministries-Institutions and regional to compile as the disaster response measure.
- To meet annually in order to evaluate and assess the impact, loss and damage and monitor for the emergency response and recovery and report to Office of the Council of Ministers and Head of the Royal Government.
- To convene the monthly meeting upon the request of Chair or an extraordinary meeting as deemed necessary in accordance with the actual situation.

# Article 4-.

Chair of coordination task force has the privilege to form up the technical sub-teams of the respective sectors and secretary team which composed of technical officers from concerned Ministries-Institutions, representatives of the United Nations, development partners, international organizations, and non-government organizations to assist through their specialized tasks and responsibilities.

### Article 5-.

Any provision which is contrary to this resolution shall be considered annulment.

# Article 6-.

Minister in charge of Office of the Council of Ministers, Minister of Economy and Finance, National Committee for Disaster Management, concerned Ministries-Institutions and interested parties are responsible to implement the respective tasks from the signing date effectively.
